In accordance with Appendix C to Works Bureau Technical Circular No. 9/97, you are requested to confirm in writing for my records on or before the above-mentioned deadline the name and post title of **one resident top management and one technical personnel** who fulfil the laid-down requirement and are full time responsible for the Site Formation category.

You should inform this Bureau in writing immediately of any factor which might affect your qualified status. This Bureau reserves the right to review your qualified status in the light of any new information relevant to your qualification.

You may be aware that tenders for contracts for Government public works are normally invited by notification published in The Government of the Hong Kong Special Administrative Region Gazette. It will be in your interest to read these gazettes in order that you may be made aware of tenders within the time allowed.

Thank you for your interest in applying for inclusion in the captioned List. I sincerely hope that you would actively tender for Government works in future and try your best to perform well in Government works contracts if given the opportunities.
